THE PARTIES

- EUROPEAN TECHNICAL SERVICES** (European Technical L.L.C-FZ), SHAMS license no. 2542059, Sharjah, United Arab Emirates, operator of the ReadySite.us platform, legally represented by **Trent Stephen Challis, Director**, hereinafter referred to as the "Company."
- The person identified below, hereinafter referred to as the "Agent," who declares under their own responsibility that the information provided is accurate and complete.

1. SUBJECT OF THE AGREEMENT

- 1.1** The Agent promotes and sells, on behalf of the Company, already-built websites offered through the ReadySite.us platform to businesses across the United States. The websites are ready-made prior to sale and can be customized at the client's request.
- 1.2** The Agent is an independent contractor. This agreement does not create an employment relationship, does not grant territorial exclusivity, and does not impose a minimum sales target.

2. COMMISSION

- 2.1** The sale price of the website is **\$899.95**. Annual hosting costs (\$49.00) and domain costs (\$24.00) are not included in the commission calculation base.
- 2.2** The Agent's commission is 50% of the website price, i.e. **\$449.98** for each sale collected in full by the Company.
- 2.3** The commission is paid, at the Agent's choice, by bank transfer, Revolut, PayPal, or USDT, to the account declared above, within 15 days of the end of the month in which the amount was collected from the client.
- 2.4** In the event of a refund, cancellation, or chargeback, the corresponding commission is reversed or withheld from subsequent payments.
- 2.5** The Agent has no right to change the price, grant discounts, or collect amounts directly from the client. Any discount granted without the Company's written consent is deducted from the Agent's commission.

3. AGENT'S OBLIGATIONS

- 3.1** Contacts businesses by phone first and sends the website link only to people who have expressed interest during the call.
- 3.2** Is prohibited from sending unsolicited bulk messages via WhatsApp, SMS, or email. Breach of this obligation is grounds for immediate termination of the agreement.
- 3.3** Does not promise features, timelines, or results that are not part of the offer published on readysite.us, and does not present themselves as an employee or authorized representative of the Company.
- 3.4** Logs the outcome of every call in the work file and immediately honors any request to be removed from the list. After every sale, sends an email to **info@readysite.us** with the website sold and the client's details, to lock the commission under the Agent's name.

4. CONFIDENTIALITY AND PERSONAL DATA

- 4.1** The contact file, website links, and sales materials are confidential, remain the Company's property, and may not be copied, transmitted to third parties, or used for any other purpose.
- 4.2** The Agent processes contact data solely on behalf of and under the instructions of the Company, in accordance with applicable US data protection and privacy law, and permanently deletes it upon termination of this agreement.

5. TAXES, TERM, AND GOVERNING LAW

- 5.1** The Agent is solely responsible for registering, reporting, and paying any taxes and contributions owed in the United States on amounts received under this agreement.
- 5.2** The agreement is for an indefinite term and may be terminated unilaterally by either party, by written notice 7 days in advance. Commissions on sales already collected remain owed.
- 5.3** This agreement is governed by the laws of the **State of Delaware**. Disputes are resolved amicably where possible; failing agreement, by the competent courts of the **State of Delaware**.
